He draws a clear connection of the power and control used in domestic and interpersonal violence, and challenges his audience to change the system to ensure the safety of the victim, police and community.

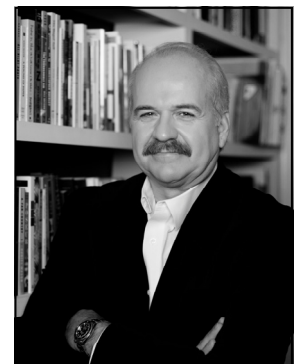
